On behalf of Sanosil International, LLC (EPA Company No. 84526), we are notifying the U.S. EPA of a change in their official company name. The new name is as follows:

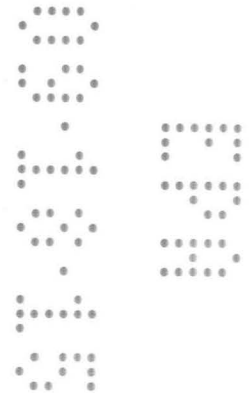
**Halosil International, Inc.**
